The seniority list of Assistant Salesman in this organization upto 31.12.1999 has already been published as per reference read as 1st and 2nd above. The provisional seniority list of Assistant Salesman in Supplyco for the period from 01.01.2000 to 31.12.2010 has been drawn up and published vide proceedings read as 3rd above. 32 claims / objections have been received against the provisional seniority list. Before discussing the claims / objections the relevant rules and principles based on which the list is drawn up are discussed below.

As per Rule 27 of KS & SS Rules 1958 the seniority list of a person is determined by the date of effective advice made for his appointment to such class, category or grade and when two or more persons are included in the same list of candidates advised, their relative seniority shall be fixed according to the order in which their names are arranged in the advice list.

In the case of candidates who have been granted extension of time to join duty beyond three months from the date of appointment order their seniority shall be determined by the date of their joining duty. In all other cases Head Office order No. and date are considered for determining the seniority.

The objections / claims received from the following officers are examined and decided as detailed below.

The above persons have requested to reckon their seniority w.e.from the date of their joining duty in Supplyco. According to them those who have joined duty in Supplyco later were wrongly included as seniors and hence requested to restore their seniority.

As per Rule 27 of KS & SS Rules 1958 the seniority of a person is determined by the date of effective advice made for his appointment to such class, category or grade and when two or more persons are included in the same list of candidates advised, their relative seniority shall be fixed according to the order in which their names are arranged in the advice list. Hence the claims of the above individuals are rejected.

- 5) M.Radhakrishnan - Sl.No.142: The individual has informed that his name is omitted from the list. The argument is not correct. His name is included in the seniority list as Sl.No.142
- 6) R.Rajasekharan Pillai - Sl.No.104 : His name wrongly spelt is corrected as R.Rajasekharan Pillai.
- 7) Shaji Kurian - Sl.No.265 : His name wrongly spelt is corrected as Shaji Kurian.
- 8) Dideep Kumar.P.S - Sl.No.270 : His name wrongly spelt is corrected as Dideepkumar.P.S.
- 9) Premnath.R - Sl.No.364: His date of entry in service is corrected as 13.01.2004.
- 10) Rajeena.P.A - Sl.No.205: Her claim is rejected as no changes are noticed in the PSC advise No. & date as well as Head Office order No. & date.
- 11) Ajith.K. - Sl.No.590: His date of entry in service is corrected as 26.06.2008. The claim for correction of date of birth is rejected as no change is detected.
- 12) Jayagosh.V – Sl.No.751: The claim is rejected as no change in Head Office Order No. & date.
