As per minutes of the Board meeting held on 14.05.18, persons with liability of Rs.40,000 & above and those having Vigilance/Police/Disciplinary cases are to be considered for by transfer / promotion only after the finalisation of those cases.

Sri.Nandakumar G, Asst.Salesman, Chalakkudy Depot, Palakkad Region was not given by transfer appointment to the cadre of Junior Assistant as per seniority since he had been reported with liability amounting to Rs.40000 and above.

Hon. High Court vide read as 2<sup>nd</sup> above ordered to consider the letter dtd 20.07.2019 submitted by Sri.Nandakumar G, requesting to grant him by transfer appointment to the cadre of Junior Assistant, within a period of three weeks from the date of order of Hon. Court.

As per the order of Hon. High Court, the letter dtd 20.07.2019 submitted by the incumbent was considered. It was found that he had remitted the liability amount of Rs.41983.83 in the account of Supplyco on 20.07.2019. It is also found that disciplinary action has been held against the incumbent in view of the inspection conducted in NFSA Godown, Mukundapuram Taluk.

Considering the Hon. High Court's order it has been decided to grant him by transfer appointment to the cadre of Junior Assistant.

Since no vacancy exists in the cadre of Junior Assistant, the junior most incumbent who was given by transfer appointment to the cadre of Junior Assistant should be reverted to the cadre of Asst.Salesman. By transfer appointment was last made vide proceedings dtd 28.09.2019 read as 3<sup>rd</sup> above. The following was the junior most incumbent who had been given by transfer appointment vide proceedings dtd 28.09.2019.

In the above circumstances the following orders are issued in compliance of the Hon. High Court's order dtd 26.10.2019.

- *Sri.Sunil Kumar P, Seniority No.742 (Koyilandy, Kozhikkode) is reverted to the cadre of Asst.Salesman.*
- *Sri.Nandakumar G, Asst.Salesman, Seniority No.420, is provisionally appointed as Junior Assistant in the scale of pay 19000-500-20000-550-22200-600-25200-650-27800-700-29900-800-33900-900-37500-1000-42500-1100-43600.*
- *The individual will be on probation for a period of 01 year within a continuous period of 02 years. The probation of the above individual will be declared only on acquiring the obligatory test of MoP or otherwise attaining 50 years of age.*
- *He is entitled for benefits of by transfer only from the date of joining in the cadre of Junior Assistant.*
- *He is allotted to Palakkad Region. The Regional Manager, Palakkad will give suitable posting to the incumbent.*
- *The by transfer appointment of the incumbent to the cadre of Junior Assistant does not in any way end or exempt him from the disciplinary action held against him.*

The Regional Manager/Depot Manager will fix the pay of the incumbent accordingly and report the date of joining of the incumbent in due course.

The order of Hon. High Court dtd 26.10.2019 in IA No.02/2019 in WA 1638/2019 is complied accordingly.
