## PROCEDURE FOR NEW VENDOR REGISTRATION/RENEWAL OF REGISTRATION OF EXISTING SUPPLIERS

- 1. The registration of suppliers with Supplyco for participating in E-Tender will be valid for a period of two years. The suppliers should renew the registration on completion of two years for further participation. All existing suppliers will be given a time of three months for renewal of their registration.
- 2. The new vendors should register through online in the website <a href="https://www.tenderwizard.com/KSCSC">www.tenderwizard.com/KSCSC</a> and upload the scanned documents before submitting the documents at Head Office for Registration.
- 3. Registration fee of Rs.35,400 ( Rs.30,000 + 18% GST) has to be remitted to the following Supplyco Bank Account

and the transaction details to be submitted along with the documents to be submitted. In case application for new registration/re-registration is denied, the registration fee remitted will be refunded.

- 4. All the vendors who have completed 2 years have to remit the renewal fee of **Rs.11800** /-(Rs.10000 +18 % GST) before 31st of every second financial year for further participation.
- 5. Copies of the following documents **certified by an authorised Notary** should be produced during registration/renewal of registration.
  - a) Certificate of incorporation (Articles of Association/Partnership deed/PAN card of the proprietor)
    - b) Details of all Directors and Partners (PAN card/Voters ID)
    - c) Certificates regarding production capacity of Mills (in the case of mills).
    - d) GST Registration Certificate
    - e) Audited accounts for the last three years
    - f) Auditors Certificate in respect of Commodities Produced/Traded for the last 3 Years.
    - g) GST return filed for the last year (GSTR 9)
    - h) Details of authorized persons (max 02 numbers) (PAN card/Voters ID/Passport and one photograph) to deal with Supplyco in what capacity.

i) FSSAI license

- j) Bank account/RTGS details in the Letter-head of the Bank with Seal and Signature.
- k) An **affidavit** in the format **(Annexure B)** to abide all the terms and conditions and rules of the Corporation and an assurance that he will not form part of any cartel to topple the interest of the Corporation.
